5-year priorities are a way to activate the master plan and are evaluated every 3 years. The current draft 5 priorities are being shared for discussion today and then will be shared with our partners for feedback before adoption by the TDC.

- <u>Building value</u> Build local tourism value through relevant tourism resources and awareness.
- <u>Thriving Economy</u> Enhance authentic experiences so business, communities and the economy thrive.
- <u>Environment</u> Encourage behaviors and practices that benefit the natural environment.
- <u>Accessible and Inclusive</u> Improve the awareness and experience of Mt. Hood Territory as an inclusive and accessible destination.
- <u>Flow</u> Drive visitation that aligns with the specific needs of a place including regional and seasonal needs.

Chair Smith is looking to add value to farm products in a way that will enhance the economy for farms. Hoping to make state land use rules more equitable with consistency in regulations for production and farming across industries. Start treating agritourism as more viable recourse and clarify rules. Considering legislation in 2025 around 'value added products to farms. These goals and next steps were discussed.
