FY23/24 Budget Approval - Samara Phelps, Executive Director

- The final budget has been shared in the packet we are looking for approval of today.
- Changes are highlighted in yellow and shared in the narrative. We do not have Allocated Costs yet, so they will change.
 - Clarification Questions how drastically with the changes change?
 - We don't know how those will change, they will go up and not down. It will come out of contingency.
 - What are the Professional Services Changes? There are 2 funds to be determined in additional Professional Services. Numbers also include RCTP, but they have revenues to match the expenditures.
 - Two changes we would like to make
 - Vehicle Maintenance & Repair we no longer have the van but we held the funds for additional storage costs. We would like to move that \$14,250 up to the Leases – Storage as we have now expanded storage at the DSB Office.
 - What happened to the van?
 - We sold it to another department
 - Additionally, we would like to take \$7,000 from Training & Development and move to program Materials & Supplies as it is for Sponsorships and this is where the Sponsorships come from.
